

The FSC Accelerator is a configuration toolset specifically designed to reduce the overall deployment time for Salesforce Financial Service Cloud. Based on best practices and industry expertise, the Accelerator provides the following additional configuration options:

USABILITY FEATURES

- Update Household Member Addresses when the household address changes
- Standardize Household Naming Convention (i.e. Smith, Matt & Jane)
- Enhanced Lead Conversion for Person Accounts: When
 using person accounts, we create a Primary Person Account
 record, secondary record (if applicable) and Household
 record, and create the relationships between them, when the
 lead is converted.
- Page Layout Standardization: We have standardized all of the page layouts, activity layouts, compact layouts, buttons, etc. to both make it easier to navigate and reduce the number of clicks required.
- FSC Training Videos/Documentation: We provide fourteen (14) short videos to educate our clients as to how FSC is designed and how it works. This includes training on the household model, Reciprocal Roles and how to relate records to other records.
